Chairman Hutcheson called the meeting to order and ask Commissioner Hale to deliver the invocation, he then ask Commissioner Strickland to lead the Pledge of Allegiance.

CONSENT AGENDA

A motion was made by Commissioner Strickland, duly seconded by Commissioner Maze and so carried to approve the consent agenda as read by Chairman Hutcheson.

SHERIFF DEPARTMENT – APPROVE REQUISITION FOR CEILING TILE FOR THE JAIL WITH BONNER'S ACOUSTICAL CONTRACTING \$6,136.00 FROM COURTHOUSE AND JAIL FUND

A motion was made by Commissioner Kilgore, duly seconded by Commissioner Hale and so carried to approve the requisition for the Sheriff's department for ceiling tile for the Jail with Bonner's Acoustical Contracting for the amount of \$6,136.00 with funding coming from the Courthouse and Jail fund.

TRANSFER CABLE FRANCHISE FROM COBRIDGE TO ZITO

A motion was made by Commissioner Strickland, duly seconded by Commissioner Hale and so carried to follow the recommendation of the County Attorney and approve the cable franchise transfer from CoBridge to Zito If 1.)CoBridge gives a credit to their customers for the time of the outage due to the April 26, 2001 storms, and 2.) Zito and/or CoBridge agree to remove the cable that has been downed from the power poles as a result of the April 27, 2011 storms or that is downed from subsequent storms from private property within 20 days of being notified that Cable is down or will agree to compensate the land owner his or her reasonable cost of the removal and disposal of the downed cable, and 3.) Zito agrees to give a credit to its customers in Marshall County, Alabama for service outages in the future.
