**ALZHEIMER'S AWARENESS MONTH SEPTEMBER 2012**

WHEREAS, Alzheimer's is a devastating disease that impairs memory, reasoning, motor skills and the ability to take care of one's self. The impact of Alzheimer's on individuals, families and our health care system makes the disease one of our nation's primary medical, social and fiscal challenges; and

WHEREAS, Alzheimer's affects every level of our society. The statistics associated with the disease are:

Alzheimer's disease is the most common form of dementia and the sixth leading cause of death in the United States.

An estimated 5.4 million Americans have Alzheimer's disease.

Over 15 million Americans provide unpaid care for a person with Alzheimer's disease or other dementias.

Currently, there are no treatments that can prevent, delay or reverse Alzheimer's disease; and

WHEREAS, Alzheimer's disease poses a grave and growing challenge to our nation, yet continued funding, unrelenting advocacy and dedicated individual efforts will make a difference; and

WHEREAS, Alzheimer's Services of Marshall County is a 501 (c) (3) non-profit volunteer organization whose mission is to provide patients and families with support, education and referral services, to advocate for improved public awareness and to support research.

NOW, THEREFORE, I James Hutcheson, by the virtue of the authority vested in me as Chairman of Marshall County Commission, Alabama, hereby proclaim the month of September 2012 Alzheimer's Awareness Month in Marshall County, and encourage all citizens to support in every way the activities and endeavors of Alzheimer's Services of Marshall County.

ANNOUNCE BID OPENING AUGUST 30, 2012 AT 2:00 P.M.

DISTRICT 2 – APPROVE SPEED LIMIT FOR ROADS IN WILLOW LAKE SUBDIVISION; 25MPH
