# <u>DISTRICT 1 – APPROVE BID INVITATION FOR ONE (1) OR MORE 4-DOOR FULL SIZE PICK-UP TRUCK(S)</u>

### <u>SHERIFF – APPROVE REQUEST TO PURCHASE PATROL CAR WITH VEHICLE</u> REPLACEMENT FUND; \$20,704.15
