The Marshall County Commission met in regular session on Wednesday, June 12, 2019 at 10:00am in the Marshall County Commission Chambers.

Chairman Hutcheson called the meeting to order and ask Commissioner David Kelley, to lead the Invocation. He then asked Commissioner Ronny Shumate to lead the Pledge of Allegiance.

CONSENT AGENDA

A motion was made by Commissioner Kelley, duly seconded by Commissioner Shumate, all members voting affirmatively and so carried to approve the consent agenda as read by Chairman Hutcheson. The consent agenda includes the minutes from the June 12, 2019 commission meeting and the claims docket for May 21, 2019 – June 10, 2019 in the amount of \$917,339.10.

DISTRICT 1 – APPROVE BID AWARD FOR CDBG PROJECT

A motion was made by Commissioner Shumate, duly seconded by Commissioner Kelley, all members voting affirmatively and so carried to approve Bid for CDBG project #CY-CM-PF-18-001. Wiregrass Contractors was the low bid at \$491,343.73. The CDBG grant was for \$350,000.00.

DISTRICT 1 – APPROVE SPEED LIMIT OF 25 MPH ON ALDRIDGE GAP ROAD
