Chairman Hutcheson called the meeting to order and asked Commissioner David Kelley to lead the Invocation. He then asked Commissioner Ronny Shumate to lead the Pledge of Allegiance.

### APPROVE RESOLUTION VACATING FEEMSTER GAP ROAD

The Public hearing to vacate a portion of Feemster Gap Road was held at the regular 9:00am work session on November 13, 2019. A motion was made by Commissioner Shumate, duly seconded by Commissioner Kelley, all members voting affirmatively and so carried to waive the reading of the resolution to vacate portion of Feemster Gap Road. A motion was made by Commissioner Shumate, duly seconded by Commissioner Kelley, all members voting affirmatively and so carried to approve the resolution vacating portion of Feemster Gap as recommended by County Engineer. Chairman Hutcheson called for a roll call vote, Commissioner Shumate, yay, Commissioner Watson, yay, Commissioner Baker, yay, Commissioner Kelley, yay.

#### RESOLUTION VACATING PORTION OF FEEMSTER GAP ROAD

WHEREAS, the District 1 Commissioner, Ronny Shumate, sought to vacate a portion of Feemster Gap Road;

WHEREAS, notice was given pursuant to Alabama Law and a public hearing was conducted on November 13, 2019 at 9:00 am in the Commission Chambers of the Marshall County Courthouse in Guntersville, Alabama; and

WHEREAS, members of the public, and/or abutting landowners did appear at the public hearing to voice objection to the said vacation;

WHEREAS, the road to be vacated is a portion of "Feemster Gap Road" that is located in Marshall County, Alabama, more particularly described as follows, to-wit:

A TRACT OF LAND LYING AND BEING 30 FEET EACH SIDE OF, PARALLEL AND CONTIGUOUS TO THE FOLLOWING DESCRIBED LINE BEING FURTHER DESCRIBED AS A PORTION OF FEEMSTER GAP ROAD LYING IN SECTIONS 8 AND 9, TOWNSHIP 9, RANGE

2 EAST, MARSHALL COUNTY, ALABAMA AND BEING MORE PARTICULARLY DESCRIBED AS COMMENCING AT A AXLE LOCATED AT THE SOUTHEAST CORNER OF SECTION 8, THEN A DISTANCE OF 1319.67 FEET TO A <sup>5</sup>8 INCH DIAMETER REBAR. THEN A DISTANCE OF 193.25 FEET TO A POINT IN THE CENTERLINE OF SAID FEEMSTER GAP ROAD, THE POINT OF BEGINNING. THEN FROM THE POINT OF BEGINNING AND ALONG SAID CENTERLINE THE FOLLOWING DESCRIBED COURSES, A DISTANCE OF 37.90 FEET TO A POINT. THEN ALONG A CURVE TO THE LEFT HAVING A RADIUS OF 77.27 FEET, AN ARC LENGTH OF 121.14 FEET, AND A CHORD BEARING AND DISTANCE OF 109.11 FEET TO A POINT. THEN A DISTANCE OF 91.60 FEET TO A POINT. THEN ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 401.03 FEET, AN ARC LENGTH OF 299.77 FEET, AND A CHORD BEARING AND DISTANCE OF 292.84 FEET TO A POINT. THEN A DISTANCE OF 81.16 FEET TO A POINT. THEN A DISTANCE OF 159.28 FEET TO A POINT. THEN A DISTANCE OF 205.67 FEET TO A POINT. THEN A DISTANCE OF 98.06 FEET TO A POINT. THEN A DISTANCE OF 188.94 FEET TO A POINT. THEN ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 284.69 FEET, AN ARC LENGTH OF 145.16 FEET, AND A CHORD BEARING AND DISTANCE OF 143.60 FEET TO A POINT. THEN A DISTANCE OF 138.08 FEET TO A POINT. THEN ALONG A CURVE TO THE LEFT HAVING A RADIUS OF 665.61 FEET, AN ARC LENGTH OF 128.04 FEET, AND A CHORD BEARING AND DISTANCE OF 127.84 FEET TO A POINT. THEN A DISTANCE OF 395.79 FEET TO A POINT. THEN A DISTANCE OF 152.98 FEET TO A POINT. THEN ALONG A CURVE TO THE LEFT HAVING A RADIUS OF 483.49 FEET, AN ARC LENGTH OF 53.35 FEET, AND A CHORD BEARING AND DISTANCE OF 53.32 FEET TO A POINT. THEN A DISTANCE OF 169.55 FEET TO A POINT. THEN A DISTANCE OF 65.34 FEET TO A POINT. THEN ALONG A CURVE TO THE RIGHT HAVING A RADIUS OF 154.71 FEET, AN ARC LENGTH OF 30.31 FEET, AND A CHORD BEARING AND DISTANCE OF 30.26 FEET TO A POINT. THEN A DISTANCE OF 26.17 FEET TO END OF SAID CENTERLINE AND CONTAINING 3.57 ACRES MORE OR LESS. ACCORDING TO A SURVEY PREPARED BY ALLEN LAND SURVEYING DATED 07-19-2019. PROJECT NUMBER 18-35; and

WHEREAS, the above described vacation is in the public interest in that the road is currently closed as a result of the flooding that occurred on December 25, 2015 and has been impassable since. Further, the cost of reopening the said portion of Feemster Gap Road has been determined to be in excess of the value and worth of having the road reopened.

THEREFORE, BE IT RESOLVED as commissioners of Marshall County, Alabama, we hereby proclaim that the portion of Feemster Gap Road is vacated, discontinued, abandoned and annulled so as to destroy the force and effect of any dedication by map, plat or otherwise and to divest any and all rights of the public, including any rights which may have been acquired by dedication of plat, prescription or otherwise in that part of the road are hereby vacated.
