DISTRICT 1 – APPROVE RESOLUTION VACATING OLD FARM ROAD (OFF HIDDEN VALLEY ROAD) A motion was made by Commissioner Shumate, duly seconded by Commissioner Watson, all members voting affirmatively and so carried to approve resolution vacating Old Farm Road (off Hidden Valley Road) as read by County Attorney.

WHEREAS, the all the property owners along OLD FARM ROAD have filed a petition to vacate it;

WHEREAS, notice of was given pursuant to Alabama Law and placed on the agenda of a regular county commission meeting for February 26, 2020;

WHEREAS, that said hearing was held as scheduled and no one who lived on the road objected to the said vacation;

WHEREAS, the road to be vacated is "OLD FARM ROAD" that lies south of, that is located in Marshall County, Alabama, as more particularly described as follows, to-wit:

The Old Farm Road to be vacated is more particularly described as follows, to wit:

All that road or right of way which is historically described as 16 feet of width as named as "Old Farm Road" that lies south of the Hidden Valley Road in the Northwest ¼ of the Southeast ¼ of Section 6, Township 8 South, Range 3 East of the Huntsville Meridian, in Marshall County, Alabama and the centerline of the road to be vacated is more particularly described as follows, to wit:

Commence at the purported to be the Northwest corner of the North one-half of the Northwest 1/4 of the Northeast 1/4 of Section 6, Township 8 South, Range 3 East in Marshall County, Alabama; thence South 01 degrees 20'00" East 624.10 feet to a point on the South margin of Hidden Valley Road; thence along the South margin of said Hidden Valley Road as follows: North 59 degrees 46'14" East 131.6 feet to a point; thence North 65 degrees 39'00" East 116.14 feet to a point; thence North 77 degrees 22'00" East 42.42 feet to a point; thence North 79 degrees 49'56" East 145.79 feet to a point; thence North 83 degrees 08'48" East 300.52 feet to a point in the center of Old Farm Road; thence in a southerly direction along and with the center line 385 feet more or less to a point on the north margin of Tract 9 of the Kearney Estate as recorded in Plat Book 8 Page 402 in the Probate Office of Marshall County, Alabama and being the ending point of said center line of Old Farm Old.
