Chairman Hutcheson called the meeting to order and asked County Attorney Clint Maze to lead the Invocation and Commissioner Ronnie Shumate to lead the Pledge of Allegiance.

ANIMAL CONTROL - APPROVE BID AWARD FOR ANIMAL SHELTER REBID
