# RESOLUTION AUTHORIZING AND APPROVING APPLICATION FOR GRANT FUNDS THROUGH THE STATE OF ALABAMA'S CDBG-CV PROGRAM

WHEREAS, the Marshall County Commission has completed its application for Grant Funds through the State of Alabama's Community Development Block Grant (CDBG) Coronavirus (CV) Program, and

WHEREAS, the Marshall County Commission concurs with objectives, needs, and program activities proposed therein, and

WHEREAS, priorities for the proposed program activities adopted by the Marshall County Commission were determined in accordance with State and Federal guidelines and determinations on eligibility of activities necessary to prevent, prepare for, or respond to COVID-19 or other infectious diseases,

NOW, THEREFORE, BE IT RESOLVED BY THE MARSHALL COUNTY COMMISSION:

- I. That the Marshall County Commission shall submit an application to the State of Alabama Community Development Block Grant (CDBG) Coronavirus (CV) Program for \$600,000.00 in grant funding to provide assistance to organizations providing specialized medical care to include mental health care, to provide assistance to emergency response assistance, to provide assistance to combatting food insecurity issues throughout the County, to provide transportation for homeless and low income individuals, and to provide on-site vaccinations to industry workers
- II. That said application was developed through a planning process that included input from Marshall County citizens, County Emergency Management Agency (EMA) officials, County Public Health Department officials, economic and development counsel representatives, and other local healthcare and community assistance providers.
- III. That said application has the support of at least two-thirds of the governing bodies representing two-thirds of the County's incorporated population.
- IV. That the Chairman is duly authorized to sign said application for and act on behalf of the Marshall County Commission and is further authorized to execute all other documents required for application or disbursement of the State of Alabama CDBG-CV funds for the Marshall County Commission.
