CONSENT AGENDA

A motion was made by Commissioner Shumate, duly seconded by Commissioner Baker, and all members voting affirmatively and so carried to approve the consent agenda presented as read by Chairman Hutcheson. APPROVE TO AWARD BID FOR THE MARSHALL COUNTY ANIMAL SHELTER REBID

A motion was made by Commissioner Sims, duly seconded by Commissioner Baker, and all members voting affirmatively and so carried to approve annual Trane Service Agreement on (2) Air- Cooled Chillers at Guntersville Courthouse for \$5,213.57 to be paid from Maintenance budget.

EMA – APPROVE PAYMENT REQUEST TO ACCESSED MANAGED SYSTEMS; \$895 COURTHOUSE AND JAIL FUND

A motion was made by Commissioner Baker, duly seconded by Commissioner Shumate, and all members voting affirmatively and so carried to approve payment request to Accessed Managed Systems for \$895 paid from Courthouse and Jail Fund.

A motion was made by Commissioner Watson, duly seconded by Commissioner Baker, and all members voting affirmatively and so carried to approve applying for Tire Disposal Program Grant offered through Alabama Department of Environmental Management (ADEM) with no additional cost to the county.

APPROVE RESOLUTION OF THE MARSHALL COUNTY COMMISSION RELATED TO THE ADMINISTRATIVE FEES RECEIVED FROM FIRE SERVICE FEES FROM ACT 2013-403.

A motion was made by Commissioner Sims, duly seconded by Commissioner Baker, and all members voting affirmatively and so carried to approve Resolution of the Marshall County Commission related to the administrative fees received from Fire Service Fees from Act 2013-403. Roll call vote: Commissioner Shumate, yea, Commissioner Watson, yea, Commissioner Sims, yea, Commissioner Baker, yea, Motion passed with 4/0.

WHEREAS, 2013 Ala Act 403 allowed for the creation of fire districts and the collection of a Fire Service Fee (the "Act");

WHEREAS, Georgia Mountain Volunteer Fire Department, Four-C Volunteer Fire Department, Hebron Volunteer Fire Department, Waterfront Volunteer Fire Department, Pleasant Grove Volunteer Fire Department, Nixon Chapel Volunteer Fire Department, Grant Volunteer Fire Department, Douglas Volunteer Fire Department, and Ruth Volunteer Fire Department have been duly created and recognized as fire districts by the Commission pursuant to the Act;

WHEREAS, a referendum vote was held for each of these fire districts and the majority of the votes cast at the election voted to collect the assessment of a Fire Service Fee at the rate of \$5.00/month for "each residence, dwelling, and business within the geographic boundaries of the fire districts";

WHEREAS, the Act requires the Marshall County Revenue Commissioner to assess, bill, collect, administer, and enforce the Fire Service Fee in accordance with the Act 2013-403.

WHEREAS, the Marshall County Commission wishes to pledge financial support to the Marshall County Revenue Commissioner's office, from the administrative fee collected from the fire district fee, for systems, software and personnel necessary to properly assess, administer and collect Fire Service Fee as required by the Act.

NOW, THEREFORE, BE IT RESOLVED BY THE MARSHALL COUNTY COMMISSION as follows:

- The Commission fully supports the assessment, administration and collection of the Fire Service
 Fees as required by the Act, and pledges such resources to the Marshall County Revenue
 Commissioner as are needed to carry out the Act.
- 2. The Act allows for the collection by Marshall County, Alabama of an administration fee on the Fire Service Fee collected. Said administration fee is deposited in the General Fund of the Marshall County Commission. The Marshall County Commission hereby pledges and commits the administration fees to be used in the collection, enforcement and administration of the Act and Fire Service Fee.
- 3. The Commission hereby pledges its willingness to fund and pay for such reasonable and necessary expenses to collect, enforce and administer the Fire Service Fee; including any software needs and upgrades as may be needed by the Marshall County Revenue Commissioner to properly administer, assess, collect, distribute and report the Fire Service Fee.
