# RESOLUTION TO TRANSFER OF P25 RADIOS PURCHASED WITH AMERICAN RESCUE PLAN ACT FUNDS TO ELIGIBLE VOLUNTEER FIRE DEPARTMENTS AND RESCUE SQUADS

WHEREAS, Marshall County, Alabama ("the County") has received American Rescue Plan Act state and local fiscal recovery funds ("ARPA funds") and is charged with ensuring that such funds are expended in accordance with state and federal law; and

WHEREAS, by way of resolution dated March 9, 2022, the Marshall County Commission ("Commission") authorized the allocation of up to \$270,000 of its ARPA funds to purchase P25 radios to be distributed to and used by the County's volunteer fire departments and rescue squads ("emergency service providers") to carry out part of the County's response to the impact of the COVID-19 public health emergency through the provision of emergency response and medical services; and

WHEREAS, the County has properly procured the radios in accordance with procurement policies and practices as required by the Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards ("Uniform Guidance"); and

WHEREAS, consistent with approval by the Commission in its June 22, 2022, meeting, award packets were distributed to each of the seventeen emergency service providers in the County seeking information needed to complete risk assessments, develop a monitoring plan, and finalize subrecipient agreements in accordance with Uniform Guidance; and

WHEREAS, the Commission desires to enter into an agreement with each emergency service provider to distribute P25 radios in order to carry out the proposed project;

### NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION as follows:

- 1) The County distribute P25 radios to each of the emergency service providers to carry out part of the County's response to the impact of the COVID-19 public health emergency through the provision of emergency response and medical services by and through subawards as follows:
  - a) 4C Volunteer Fire Department 5 radios;
  - b) Alder Springs Volunteer Fire Department 5 radios;
  - c) Asbury Volunteer Fire Department 5 radios;
  - d) Beulah Volunteer Fire Department 5 radios;
  - e) Douglas Volunteer Fire Department 5 radios;
  - f) Georgia Mountain Volunteer Fire Department 5 radios;
  - g) Grant Volunteer Fire Department 5 radios;
  - h) Guntersville Rescue Squad 5 radios;
  - i) Hebron Volunteer Fire Department 5 radios;
  - j) Mt. Hebron Volunteer Fire Department 5 radios;
  - k) Pleasant Grove Volunteer Fire Department 5 radios;
  - South Sauty Volunteer Fire Department 5 radios;
  - m) Swearengin Volunteer Fire Department 5 radios;
  - n) Union Grove Volunteer Fire Department 5 radios;
  - o) Union Rescue Squad 5 radios;
  - p) Wakefield Volunteer Fire Department 5 radios; and
  - q) Waterfront Volunteer Fire Department 5 radios.
  - 2) Distribution of the radios are subject to the following conditions:

- a) Completion and return of the award packet materials by each of the emergency service providers:
- b) Completion of a satisfactory risk assessment for each emergency service provider;
- c) Development of a monitoring plan for each emergency service provider; and
- d) Execution of a subrecipient agreement in a format that is substantively similar to the form agreement attached to this Resolution as Addendum 1.
- 3) The Chairman is hereby authorized to execute the subaward agreements.
- 4) The Marshall County EMA is hereby authorized to distribute the radios in accordance with the terms of this Resolution and the executed subrecipient agreement, the terms of which are incorporated by reference herein.
