Chairman Hutcheson called the meeting to order and asked County Attorney Clint Maze to lead the Invocation. He then asked Commissioner David Kelley to lead the Pledge of Allegiance.

A motion was made by Commissioner Shumate, duly seconded by Commissioner Kelley, all members voting affirmatively and so carried to approve the consent agenda as read by Chairman Hutcheson. APPROVE REQUEST OF ATTORNEY GENERAL'S OPINION ON WHETHER CONTRACTED CONSULTANT FOR MAPPING & APPRAISAL SHOULD BE COVERED UNDER THE PERSONNEL BOARD

A motion was made by Commissioner Baker, duly seconded by Commissioner Shumate to request Attorney General's Opinion on whether contracted consultant for Mapping & Appraisal should be covered under the Personnel Board. The motion passed with two Yay's (Commissioners Baker, Shumate) and one Nay (Commissioner Kelley).

APPROVE REQUEST OF ATTORNEY GENERAL OPINION ON MAIL-OUT SERVICES FOR PROBATE AND REVENUE COMMISSION

A motion was made by Commissioner Baker, duly seconded by Commissioner Shumate, all members voting affirmatively and so carried to approve request of Attorney General Opinion on mail-out services for Probate and Revenue Commission.

EMA – APPROVE SUBAWARD AGREEMENT FY2019 EMERGENCY MANAGEMENT PERFORMANCE GRANT 19EMF; \$43,357.00, NO MATCH

A motion was made by Commissioner Kelley, duly seconded by Commissioner Baker, all members voting affirmatively and so carried to approve subaward agreement FY2019 Emergency Management Performance Grant 19EMF for \$43,357.00, no match.

<u>EMA – APPROVE 25% FEDERAL FUNDING INCREASE FOR THE EMERGENCY MANAGEMENT PERFORMANCE GRANT 19EMS; \$12,000, NO MATCH</u>

A motion was made by Commissioner Kelley, duly seconded by Commissioner Baker, all members voting affirmatively and so carried to approve 25% federal funding increase for the Emergency Management Performance Grant 19EMS for \$12,000, no match.

JAIL – APPROVE \$10,000 FROM COURTHOUSE & JAIL FUND FOR RENTAL AND SET-UP OF MOBILE TEMPORARY OFFICE FACILITY FOR DISPATCH

A motion was made by Commissioner Kelley, duly seconded by Commissioner Shumate, all members voting affirmatively and so carried to approve \$10,000 from Courthouse & Jail Fund for rental and set-up of mobile temporary office facility for dispatch.
