- (1) The successful bidder shall begin furnishing materials within five (5) working days after receiving notice to proceed.
- (2) All materials must comply with requirements of Division 800, Section 801 of the 2022 Edition of the <u>Alabama Department of Transportation Standard Specifications for Highways Construction.</u>
- (3) In selecting the plant from which the individual loads will be called for, the distance of haul from the plant to the job site will be considered in the cost.
- (4) The Marshall County Commission reserves the right to award this contract as a whole or in part, whichever is in the best interest of Marshall County.
- (5) It is the bidder's responsibility to familiarize himself with and shall comply with all requirements and specifications as stated in the <u>Alabama Department of Transportation Standard Specifications for Highway Construction-2022 Edition</u>. The definition for "State" as listed in the before mentioned manual, in Section 101.01, shall be changed to read as follows: "Marshall County, a political subdivision of the State of Alabama, the party of the first part to the contract acting by and through the Marshall County Engineer".
- (6) It shall be the bidder's responsibility to possess all proper County, State, and Federal license and shall familiarize himself with and shall comply with all Federal, State, and local laws, ordinances, and regulations.
- (7) This bid shall be good for the period beginning October 1, 2024 and going through September 30, 2025. However, an option to issue a second and third 12-month contract with the same pricing, terms and conditions is possible. The second or third contract, if agreed by both parties, would begin the day after the first or second contract expires. Any successive contract must have the written approval by the County and the vendor.
